FACULTY ASSEMBLY/SENATE MEETING MINUTES

Senator Chair Rasoul Saneifard called the May 2013 meeting of the TSU Faculty Senate to order at 3:12pm on Thursday, May 2, 2013.

Approval of the 4 April 2013 Senate Meeting Minutes

The minutes from April 2013 were read and approved subject to any additional corrections.

Provost Dr. Ohia Q / A

- Q: Senator Sharlette Kellum Gilbert, Faculty suggested a request for one individual in the department for advisement of students. The request was denied by the administration.
- A: Provost Ohia, The advisement is a critical factor for progression and graduation.

Senator Emiel Owens and Senator Macaulay Akpaffiong volunteered to serve on the committee.

- S: Senator Alexis Brooks de Vita, Follow-up regarding advisement of students
- A: Provost Ohia, A program Degree Works and Grades First will provide additional support for advisement.
- Q: Senator Daniel Georges-Abeyie, It is important if students attend courses regularly. This is not occurring. The data supports that our students are currently scoring at the threshold below an open admission institution. While the institution has implemented closed admission, it will still take six years for all new policies to take place.
- A: Provost Ohia, It will take a minimum for the current policies to take place a hold.
- Q: Senator Dr. Lalita Sen, Is there a policy in place for students regarding attendance?
- A: Senator Chair Rasoul Saneifard, Currently there is a maximum of 10% absence policy for attendance over a semester.
- A: Senator Chair Rasoul Saneifard, What is the policy regarding faculty for the summer teaching load?
- Q: Senator Mammo Woldie, There is a concern regarding the format for selecting courses for the summer schedule, it may affect progression and graduation rates.
- A: Provost Ohia, Send formal report on issues.
- Q: Senator Vice Chair Vera Hawkins, Is there a former process for reviewing data for making decision regarding SACS?

Senator Daniel Georges-Abeyie: Regarding comments of President Rudley's memo on promotion and tenure. There seems to be a direct conflict with the faculty manual regarding the Promotion and Tenure memo issued.

A: Provost Ohia, The chair is only making a recommendation on promotion and tenure status and eligibility.

Report

-IT Survey (One semester, Spring 2013)

Senator Karma Sherif

Concern on faculty load weighted heavily in some departments, but not in others – This is a concern regarding long term strategic quality of teaching and learning.

Several Senate Faculty Members (Senator Angie Eaton, Senator Chair Rasoul Saneifard, Senator Daniel Georges-Abeyie, Q: Senator Mammo Woldie, Senator Robert Ford, and Senator Vice Chair Vera Hawkins) voiced concerns regarding further evaluate each academic unit for unique course lecturing format (For example: College of Pharmacy – team course lecturing format).

What about laboratory course lecturing contact? How is it counted in the faculty load?

- Suggestion, that there is not a clear policy on course load, with regard to exception.
- Suggestion, that there should be a correct work load report to provide accurate data collection.
- This will be difficult to implement across each department and each academic unit.
- Suggestion, there is a need to return to the original work load policy.
- Comment, a state objective is for a common work load report, that is higher than Texas Southern University's current policy.
- Comment, a program in place for the \$10K degree was for adjunct type professional experience faculty teaching freshmen and sophomore level courses.

Senator Karma Sherif

A need for a presentation by Deans and Chairs to present formal core target goals for each academic unit for assessment based on a metric system by each individual course. That allows for benchmarks to measure each decision that is made on these core target goals.

Senator Daniel Georges-Abeyie and the Dean of School of Public Affair, in an initial meeting after the Department of Administration of Justice Grievance Committee dismissed a grievance brought forward by a group of students against a faculty member in the SPA. Provost Ohia met with Chair Saneifard and Professor Carrington, and indicated that the Grievance committee ruling was correct. The grievance Committee was asked for a courtesy rereview of the process. The committee met again to review the material and concluded that it would stand with the initial ruling. The TSU Faculty Senate agreed that Senator Georges-Abeyie acted properly.

Senator James Opolot, Voiced concern on information provided and that Senator Daniel Georges-Abeyie is not respecting the protocol. Senator James Opolot left the meeting after making his statement.

Senator Daniel Georges-Abeyie, Provided the language of the formal protocol that is taken by the grievance committee and that in fact the proper protocol was taken. The Provost went to the Dean of the Graduate School to seek additional information on how to address the issue. Again, Senator Daniel Georges-Abeyie wanted it on record in the minutes that he did not violate proper protocol of the grievance committee.

Senator Chair Rasoul Saneifard, Provided information that he supports the current faculty manual on grievance issues and no inappropriate action was taken by Senator Daniel Georges-Abeyie.

Senator Vice Chair Vera Hawkins, Voiced supports of faculty in regards to violations of their rights.

Senator Lila Ghemri announcement of her last meeting as apart of the faculty senate was recognized by Senator Chair Rasoul Saneifard and Senator Vice Chair Vera Hawkins for her great service.
